## **Health Services for Children with Special Needs, Inc. (HSCSN) Relocates Family and Community Development Outreach Department to the National Children's Center building in Congress Heights.**

*Open House on March 28th celebrates Health Services for Children with Special Needs, Inc. new partnership with National Children's Center, Inc.*

Washington, D.C. (March 18, 2019) – The District of Columbia's only dedicated Medicaid Health Plan for Supplemental Security Income (SSI) eligible youth (ages 0-26), has relocated its outreach team to the National Children's Center, Inc. (NCC) building in Congress Heights, Washington D.C. HSCSN and NCC are excited about the opportunity to together create a community hub centered on supporting children, youth and families, particularly those with special health needs.

Health Services for Children with Special Needs, Inc. (HSCSN) and NCC work to empower local residents with complex medical conditions. HSCSN coordinates high-quality health care and connects D.C. families with accessible resources through their community support programs. Similarly, NCC offers a full array of community-based services to people with complex health conditions—from early learning centers to residential support and transition assistance. These two mission-driven organizations continue to increase the quality, standards, and accessibility of care for people with complex medical needs throughout the District of Columbia.

The two organizations will host an **Open House** on March 28, 2019 to celebrate their formalized partnership and introduce the community to the HSCSN family and community development team who will share space with the NCC Early Learning & Early Intervention Center (ELC) at 3400 Martin Luther King Jr. Ave, SE D.C. 20032. The Open House will feature a ribbon cutting ceremony at 10:00 am, and two receptions to accommodate the community from 10:30 am - 1:00 pm and 5:00 pm - 7:30 pm.
