Dear HSCSN Provider,

The purpose of this notice is to alert you of recent updates to COVID-19 vaccination and safety requirements in the District of Columbia (District).

In the District's announcement dated August 16, 2021, Mayor Muriel Bowser released new COVID-vaccination timeframes applicable to all District health care professionals. The new timeframes require that all health care professionals and/or health care workers receive at least the first dose of the Pfizer or Moderna or one dose of the Johnson & Johnson vaccine by no later than **September 30, 2021**.

This vaccination requirement applies to:

- All licensed, certified and registered health professionals;
- All emergency services (EMS) providers (i.e. paramedics, emergency medical technicians (EMTs);
- All unlicensed health care workers (i.e. patient care technicians, personal care aides, environmental services staff)

Health care workers must also be <u>fully</u> vaccinated (one dose of Johnson & Johnson or two doses of Pfzier or Moderna) prior to:

- The submission date for application or renewal for licensure, certification, or registration with the District (including DC Medicaid enrollment)
- The start date of employment or a contractual relationship in cases where licensure is not required
- Any date specified by the DC Department of Health in written or electronic communication to the person/applicant, as applicable.

In addition to the Mayor's vaccine mandate, DC Health through emergency rulemaking, has now mandated that a person licensed to practice one of the identified professions (identified in DC Health's, August 11, 2021 communication) must complete two (2) hours of continuing education on COVID-19 vaccines, including, but not limited to, COVID-19 vaccine safety, best practices for counseling patients about COVID-19 vaccines, and COVID-19 vaccine efficacy and effectiveness, on or before September 30, 2021. These hours of continuing

education may be counted as hours required for public health priorities training hours or optional training hours where applicable.

You can view a copy of these requirements on the District's website at https://content.gov/release/mayor-bowser-and-dc-health-announce-vaccination-requirement-district-health-professionals and DC Health's training communication at https://content.govdelivery.com/accounts/DCWASH/bulletins/2ec4302. Some professionals or workers may be exempt from the vaccination due to religious beliefs, or medical conditions. All HSCSN Network Providers should review the District's approved exemption protocols and employ the appropriate safety measures, where applicable. As an HSCSN Network Provider, you play an integral role in our COVID-19 recovery and response plan. This includes ensuring enrollee access to safe, continuous care during these challenging times.

If you have not already done so, we urge you to implement the necessary steps within your practices, offices, and/or facilities to ensure staff compliance with the vaccination requirements prior to the <u>September 30, 2021</u> deadline. Should your practice or organization encounter challenges in meeting the required vaccination timeframes or training requirement(s), you <u>must</u> immediately notify HSCSN in writing, providing a remediation plan and timeframe for achieving full compliance. Written correspondence should be submitted to: **HSCSN Compliance** at <u>Compliance@hschealth.org</u>. Failure to comply with the vaccination requirements may result in the suspension of your in-network status with HSCSN or termination of your Participating Provider Agreement.
